Indeed, the Council have recommended a number of sites within the Green Belt are acceptable for development. Policy P4B is further welcomed as it enables development at other locations within the Green Belt outside of these specified locations.  Policy P5 – Provision of Land for Housing is also welcomed and the supporting table Allocated Sites 226. Summary Table of Residential Allocations should be amended to include sites in which housing can be provided such as the Barns at Eastcote on Barston Lane which is a brownfield site suitable for housing.
