The building of 780 new homes in the Knowle area makes NO provision for extra community facilities to cope with the increased population

- Yes there is a new School, but this will take most if not all of the Community Infrastructure levy leaving nothing left for other required facilities
- Yes there is a new football club, but this is only replacing the existing one.

There is NO provision for any additional GP or NHS Dental capacity – yet these are already at capacity

There is NO provision for any additional youth groups or activities – yet these are already at capacity

There is NO provision for any expansion of voluntary run community facilities.

There is vague mention of parking improvements and a single road junction improvement. Yet there are already significant parking issues in Knowle and traffic issues on Station Rd, Lodge Rd, & High St. There needs to be specific and detailed improvements built into the plan, properly funded, and implemented before any new houses are built

Whilst the building of houses on the previously developed land on Hampton Rd on the old nursery site may be logical, the building on Green Belt to the south of Knowle should not take place whilst there exists significant Previously Developed Land is the wider West Midlands area
