We support the Council's recognition as to the importance of the historic environment to the Borough's local character and distinctiveness, and to civic pride and the cultural, social, environmental and economic benefits that conservation brings.

Criteria 3 sets out a development management policy which refers to a recognised process of assessment, involvement, evaluation and design. It is not clear however what this recognised process is. The policy is imprecise as a result, and requires greater clarity.

The NPPF sets out a clear policy framework for dealing with heritage assets at paragraphs 195, 196 and 197. This hierarchical approach is more precise than the provisions of Policy P16 and provides for more clarity in a development management context.
