MHL is a narrow residential road, much of it with no pavement. It would not be appropriate for this to be used as a temporary access point in order to commence building some units on this site prior to the relief road being constructed. This would cause loss of amenity to the local residents and road safety issues due to construction vehicles and increased residential traffic using MHL.

This policy paragraph currently states 'provision of a section of the Balsall Common Relief Road between Station Road and Waste Lane as the first phase of the development'. Although the plan acknowledges the need for a relief road (text paragraph 527) the policy only provides provision for half of the road to be built. This could lead to an increase in traffic down Windmill Lane, a rural residential road with no pavement, disturbing the historic setting of the Berkswell Windmill. An incomplete Bypass will discourage usage as it will not link in with the major road network. Hence traffic will be less likely to use it and it will not perform its purpose.

Frog Lane is an ancient thoroughfare which will form the defensible boundary of this development. The current wording would allow for a variety of interpretations as to how this character could be 'maintained' and it does not provide explicit protection.

The SMBC illustrative Concept Masterplan (page 37) notes 4 future access points, one from Kenilworth Road and 3 from Wootton Green Lane. Wootton Green Lane is narrow and very rural with a large number of mature trees and hedgerows. Most of the lane would not allow 2 cars to pass. Having 3 access points would likely lead to overuse of this lane, particularly by traffic avoiding the busier Kenilworth Road. The concept masterplan also does not take into account the new roundabout by Park Lane currently being built by HS2.
