- The Policy KN2 Concept Masterplan follows a Placed Based approach and I believe will benefit all parts of the local community over the term of the Local Plan and beyond.
- The proposed Concept Masterplan is the outcome of a lengthy collaborative approach involving landowners, Arden Academy, parents, students, and many members of the local community who, alongside the Council, have sought to establish a Place-Based concept masterplan that all parties can support in principle, as an effective solution to meeting the needs of the whole community. This will specifically benefit the educational needs of a growing school aged local population, in a modern, safe environment. The concept of safety is paramount and the revised location will prove to be significantly enhanced, providing a safe community for the students and colleagues and improve local road safety (Station Road).
