We **object** to the policy wording that a minimum standard should be applied across the whole Borough in relation to green space. This should be something that is informed by ward level data, as set out in the open space assessment and taking into consideration at a site by site basis at the planning application stage. Strategic priorities can be set, but to provide a specific green space standard at a Borough wide level is unduly onerous.

We **object** to the requirement in point 10 that new development should look to accommodate the needs of existing population. Although it is likely that the existing population will use any open space provided, it should be remembered that any contribution or enhancement to be agreed through a section 106 agreement should be directly related to the development and take account of the tests of regulation 122 of The Community Infrastructure Levy Regulations (2010) and NPPF paragraph 54 and 56.

6. Point 10 of the policy should be amended to remove the reference to a Borough wide minimum standard of Green Space, as this is does not allow the policy to be effective.
