We support the provisions of Policy P21 and the need for developer contributions and infrastructure provision in principle.

However, these provisions can only be promoted where the developer contributions and infrastructure provision meets the three CIL tests, specifically;

- Necessary to make the development acceptable in planning terms;
- Directly related to the development; and
- Fairly and reasonably related in scale and kind to the development.

As drafted, whilst the policy makes passing reference at various points to the provisions of the CIL tests, these are not explicit. As a result, the policy is imprecise and it is not clear whether its operation would be discordant and at variation with the CIL provisions.
