The prosed development of 230 residences on this green filed area places an unmanageable increase in the traffic along the access road to the site as this lane is single lane in both directions from the proposed access points to the development and the >> 500 vehicles movements along Wootton green lane from these 230 residences is not achievable on the road network. There will be significant congestion as a result. The access to the A452 at either end are problematic for the low levels of traffic flow already using the road.

Access to The School in the village is beyond reasonable walking distance for children and will thus significantly increase the traffic flows along the access roads and also increase congestion and pollution within the village.

There is also very limited capacity at the schools in Balsall Common and Berkswell to cope with the increase in pupils the increase in housing within Balsall Common (Continue on a separate sheet /expand box if necessary)
