Policy P9 (Mitigating and Adapting to Climate Change) is unsound because it is ineffective and inconsistent with national policies concerning climate change. In particular, the zero-net-carbon commitment set out in the Climate Change Act 2008 (2050 Target Amendment) Order 2019 and the ambitions of the Council's Climate Change Emergency Declaration (8 October 2019) cannot be achieved without closer integration of development policies with a strategy for the Borough's trees.						
It is widely recognised that trees make a valuable contribution to many environmental objectives relating to climate change, including the sequestration of carbon, retention of storm water, regulation of temperature extremes and cooling of urban spaces, screening of UV, and the improvement of air quality. However, the potential benefits from the Borough's trees will not be realised unless development is in line with a clear tree strategy, which is evidence-based, realistic and comprehensive. Key aspects of a tree strategy need to be embedded in the Plan policies.

Policy P10 (Natural Environment) is unsound because it is ineffective in achieving the stated goals with respect to the Arden landscape and ancient woodland.

The expression of the value of trees in monetary terms is a useful adjunct to planning decisions. The Capital Asset Valuation of Amenity Trees (CAVAT) is an objective calculation method, first developed by the London Tree Officers Association (LTOA) in 2008. It contains a unit value factor that is revised periodically.

Policy P14 (Amenity) is unsound because it is ineffective in achieving the stated goals with respect to safeguarding and replacing trees, hedgerows, natural habitats and woodlands.					
Trees are essential for the amenity of an area, and are known to bring social, physical, and psychological benefits. A number of schemes for re-planting or landscaping have failed to achieve their objectives because of a focus on numbers - often poor quality whips - rather than quality and size. It is hard to see how any process could ensure compliance over a timescale of decades, so it is particularly important that proposed planting schemes for trees are rigorously examined at the outset for their potential and practicality.					
Tree planting schemes should be assessed with a standardised methodology that takes account of the proposed species, environmental conditions, growing space next to buildings, and the likely long-term management regime. To focus attention on the desired outcomes, the most appropriate metric would be the projected canopy cover 30 years from the date of planning approval.

Quite rightly, the draft Local Plan contains many references to trees. However, they are fragmented among several policies with little provision for coherent overall planning. The Local Plan will be more effective if the management of all of the Borough's trees is covered by a single new Policy for Trees.

It is widely recognised that trees make a valuable contribution to many environmental objectives relating to climate change, including the sequestration of carbon, retention of storm water, cooling of urban spaces, screening of UV, and the improvement of air quality. They also make a huge contribution to visual amenity and biodiversity, and thus improve the living conditions, physical health, mental health, social relationships, wellbeing, and productivity of the residents of the Borough.

The Solihull Urban Forestry Strategy (2019-2029) is a welcome foundation, but the integration of the strategy into the development policies is insufficient to achieve the Council's Vision for the Borough.

The potential benefits from the Borough's trees will not be realised unless development is in line with a clear tree strategy, which is evidence-based, realistic and comprehensive. The zero-net-carbon commitment set out in the Climate Change Act 2008 (2050 Target Amendment) Order 2019 and the ambitions of the Council's Climate Change Emergency Declaration (8 October 2019) illustrate this need.

With the emphasis on sustainable development in the National Planning Policy Framework, it is now an appropriate time to introduce an overall policy for the management of all trees in the Borough, both public and private. A Policy for Trees should be added to the Policies section of the Plan.

"The council will prepare a Master Plan for Trees which will contain detail requirements under the following headings:

- Aims and objectives
- Assessment of current tree inventory
 - o Species, condition, canopy cover
 - o Geographical location
 - Growing conditions, land use, geology
 - Valuation
 - o Environmental benefit assessment
- Sustainable management
 - Risk assessment
 - o Planning, building subsidence, preservation orders
 - Maintenance
 - Pest and diseases
 - Biodiversity
 - o Replacement
 - Emergency works
- Design, planning and development
 - Species and age diversity
 - Climate change
 - Societal factors
 - o Finance, budget, fund-raising
 - o Standards and methodologies
 - o Consultation
 - o Planting
 - o Care
- Tree strategy action plan
 - Public land
 - Highway land
 - o Private land
 - o Community participation
 - Verification scheme
 - Monitoring
 - Review and amendment"
